**Sitting at 12 noon on July 13th**

*The Barons and Common Baron Bailie Presiding*

1. Declarator: *Curiis et earum exitibus*
2. Baron Sergeand Shall Proclaim Notice to All & Sundry Whom These Presents Do or May Concern then *Fence The Courts*
3. Officers of the Courts Not Yet Sworn Shall Swear the Oath *de fideli administratione*
4. The Clerk of the Courts Shall Read the List of Petitions & Complaints Received for Consideration
5. The Clerk Shall Call Each Petitioner or Complainter in Turn
  - [01] Authorisation to Re-enact as a Bagpipe Opera – Tulsa
  - [02] Absolute Pardon for Witches & Their Cats
  - [03] Affirmation of boundaries and extent of ancient Lands and Crown Baronies.
  - [04] ByrLaws for The Prestoungrange Gothenburg & Declaration of July 23rd henceforth as *Gothenburg Day*
  - [05] Collection of 1753 Impost of 2d Scotch per pint on Fowler's Ales Sold from May 8th 2004
  - [06] Entitlement to Duthus Plant Badges and Slughorns for the Baronies and All Other Acquired Property Rights

  - [11] Proclamation of Compleat Discharge of Feu Duties in These Baronies; and Motion of Cessation of the Authority of the Judicial Divisions of These Courts – both to become effective at midnight on November 27th 2004.
6. Adjournment of Courts for Luncheon and Consideration
7. Such Judgements and Declarators as May Be Made Readily by the Courts
8. Adjournment of the Courts until 12 noon on July 27th 2004 when Any Further Complaints Received by 12 noon July 26th 2004 will be Considered and when Judgements and Declarators on the Outstanding Matters Above will be Given.

### **Sitting at 12 noon on July 27th**

- 9.** The Baron Sergeand shall once again *Fence the Courts*.
- 10.** Such Judgements as were held over from July 13th shall be given.
- 11.** Any further Complaints received at the Caput by the Clerk of the Courts by 12 noon on July 26th shall be considered and Judgements given.
- 12.** Adjournment of the Courts *sine die*.
