**MARK KER.**

1st Earl of Lothian and Lord Newbattle  
received charter of baronies of Newbattle  
& Prestoungrange 1587. Died 1609.

**ROBERT KER.**

2nd Earl of Lothian  
disposed of Prestoungrange 1609.



**MORISON**

George, Treasurer of Edinburgh  
Prestoungrange 1609 died 1645.

**SIR ALEXANDER MORISON OF PRESTOUNGRANGE**  
Lord of Session as Lord Prestoungrange 1626, born  
1579 died 1651

**ALEXANDER MORISON OF PRESTOUNGRANGE**  
Lord of Session as Lord Prestoungrange 1653, matric-  
ulated Arms Court of the Lord Lyon 1632 died 1653

**WILLIAM MORISON OF PRESTOUNGRANGE**  
Member of Parliament for Haddington, Berks-  
shire and Sutherlandshire. Sold Prestoungrange  
1739, died same year

**ROBERT DE QUINCY**  
occurs in Scotland 1103. Accom-  
panied King Richard lion-  
heart on crusade 1190. Gave  
Prestoungrange to Abbey of New-  
battle 1190 and died 1197.

**ORABLE** daughter and  
heiress of her son of William  
Lord of Leuchars in Fife. lady  
of Prestoungrange and other  
lands. Married, secondly,  
Gilchrist, 3rd Earl of Mar.


